**Information clause**

In accordance with Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: „the RODO Regulation”), we inform you that:

7. The recipients of your personal data are persons authorized by the Administrator, who deals with the organisation of the Forum, Forum’s partner companies, Forum’s media partners and persons authorized to obtain personal data under the law.
8. With regard to processing for the purposes specified in point 3, your personal data will not be transferred to a third country/international organisation.

11. You have the right to lodge a complaint to the supervisory authority, which is the President of the Office for Personal Data Protection, if you consider that the processing of personal data concerning you violates the provisions of the RODO Regulation.
